Hence pursuant to the relevant provisions of Securities Contract and Regulation Act, 1956 & Insolvency & Bankruptcy Code, 2016, promoters shareholding shall be reduced to 75% or less within the period of three years as the time frame provided for a company came out of Insolvency through approved resolution plan by Hon'ble NCLT.

The Company has made application for reclassification is made under Regulation 31A(9) of SEBI (LODR) Regulations 2015 pursuant to resolution plan approved under Section 31 of the Insolvency & Bankruptcy Code, 2016 approved vide order dated March 10, 2022. Accordingly, there is a change in promoters of Bartronics India Limited (Company) and that the Successful Resolution Application should be re-classified as Promoter of the Company.
